Guest Speakers:

 Jennifer Helbert: District 17 Senior Probation and Parole Officer. A PowerPoint presentation on The Gender Responsive Policy... (women in corrections) was presented to the group. The presentation will be shared on the HCCC website after approval from the source is received. Less likely to have disciplinary reports. The result is a burden on the children. Most report homelessness. Many on foster care at some point. 53% did not finish high school. More likely to be jobless prior to arrest. Over 58% SAD. Mental health history is 47%. Most living with their children upon arrest. Most include an unhealthy relationship. Large homeless population in Bristol. 1791 District 17. 563 women. Largest percentage in Virginia. Oxycontin 1996. 65% higher overdose rate. Dopesick and Pain Killers cover this. Drug misbranding \$600 million penalty. Addiction became generational. Selected 200 women to participate. Housing and childcare were issues. Available jobs were primarily low wage positions. Inconsistent service availability through CSB's due to staffing issues. Transportation was a major issue. Yearly vulnerability assessments. Will begin conducting exit interviews. CSB's are restricted from hiring women with barrier crimes. Will include gender responsivity to performance evaluations.
